## 6<sup>TH</sup> GRADE SEA WORLD FIELD TRIP

*As a part of the sixth grade curriculum integration, we are taking a field trip to Sea World on Monday, May 11, 2020*

- ❖ **Schedule:** Students must arrive at school no later than **9:15 a.m.** We will be returning to school by **5:30 p.m.** (barring any traffic delays) Parents will need to pick up their child(ren) at school at that time. Please be at school rather than waiting for your child to call you. Pick up will be at the back of the school.
- ❖ **Trip Cost:** A fee of \$65 is due **no later than Wednesday, April 1<sup>st</sup>** to cover each student's admission to the park (lunch included), field trip t-shirt and the bus ride. If your child has an annual pass to the park, the fee is \$35 to cover the bus ride, T-shirt, and lunch. Students must bring their pass to school so we can make a copy by Wednesday, April 1<sup>st</sup>. They must also bring their pass the day of the field trip and show it to us prior to departing school. Any annual pass holder who does not bring their pass on the day of the trip will not be permitted to attend.
- ❖ **Lunch:** Each student will receive a meal voucher from SeaWorld to be used in the park for lunch. Students may bring their own lunch; however, SeaWorld no longer allows coolers. Students that bring lunch are responsible for it at all times.
- ❖ **Scholarship Donations:** This should be a great 6th grade field trip. However, because of the magnitude, it is more expensive than some field trips in the past. **If you would like to make a donation to help those unable to attend for financial reasons, you may include that donation with your child's fee as well.**
- ❖ **Cancellations:** Due to the requirement of advanced reservations and booking, this fee is non-refundable after April 1<sup>st</sup>. **REFUNDS CANNOT BE GIVEN** even to students who miss the trip due to tardiness or absence. These special-event tickets are only good for May 11th. All students and chaperones must ride the bus to and from the park. Students may not join a group even if their parent takes them to Sea World independently. No exceptions will be made.

Please return the signed permission slip along with your money (or SchoolPay code) to your Science teacher by **Wednesday, April 1<sup>st</sup>**. Permission slips and money will **not** be accepted after Wednesday, April 1, 2020.
